**New Voter ID Law**

Before heading out to vote, don't forget to bring a valid form of identification (ID). A new state law requires all voters to provide ID when they vote. Any form of ID from the following list is acceptable:

- Colorado Driver's License
- Colorado Department of Revenue ID card
- U.S. Passport
- Governmental Employee ID card with photograph
- U.S. Military ID card with photograph
- Medicare or Medicaid card

- Certified copy of a U.S. Birth Certificate
- Certified documentation of Naturalization
- Pilot's License
- A copy of a current utility bill, bank statement, government check, paycheck or other government document that shows your name and address.

If the document you are bringing has an address, that address must be in the county where you are voting. If you come the polls without ID, you may vote using a provisional ballot. Provisional ballots are processed and counted after the election. If the Election Commission can verify that you were eligible to vote, your vote will be counted.

If you are voting by absentee ballot, you will need to provide a copy of your ID (from the above list) along with your ballot, only if you are a first-time voter who did not already provide ID at the time of registration. You should receive written instructions when you receive your ballot. If you do not submit required ID, your ballot will be processed as a provisional ballot.

### **About the Ballot**

In this Primary Election, if you are a registered Democrat or Republican voter, you will be choosing candidates for your party's nomination. Denver voters will also be deciding on Initiative 100 which, if adopted, will establish an ordinance prohibiting non-accredited organizations to display wild or exotic animals for public entertainment.

If you are an unaffiliated voter who is not voting by absentee ballot, you may, if desired, declare a party affiliation at an early voting location or polling precinct at the time of voting. Otherwise, you will only have one item on your ballot, Initiative 100.

### **Special Note for Absentee Voters**

Remember, if you have submitted a request for an absentee ballot, you cannot participate in early voting or vote on Tuesday at your precinct polling place. Also, do not leave any ballots with anyone except election judges at the above locations.

The Election Commission must receive your absentee ballot no later than 7 p.m. on August 10. Ballots received later than this will not be counted.
